Participant's Agreement

The purpose of this Participant's Agreement is to identify personal behavior that is consistent with the purpose and objectives of the YMCA Blue Ridge High School Christian Values Conference program. The items within this Agreement are based upon performance and are designed to protect the welfare of the program for future generations. Participation in any YMCA Blue Ridge program indicates personal acceptance of this Participant's Agreement.

EXPECTATION OF STUDENT	PENALTY FOR VIOLATION
1. All participants share the responsibility of their actions equally when violations of the Participant's Agreement are witnessed. Those who choose to be present when a violation occurs shall, by their own choice be considered participants in the violation. In relation to this Agreement, there are no "innocent bystanders."	As outlined in this Agreement
2. Each participant is legally and financially liable for the removal, defacing or willful damage to Blue Ridge property. This includes the property of fellow participants. Any act of vandalism, destruction of property, or misuse of a facility may be a crime and will be treated as a potential criminal violation.	Call parents - send home Call facility security (Possibly) Summon police
3. The use of incense or tobacco products, and the use of/possession of tobacco products, incense, candles, alcoholic beverages, weapons, or or non-prescription drugs are prohibited at any YMCA function.	Call parents - send home (Possibly) Call facility security (Possibly) Summon police
4. Male and female participants may not visit in each other's rooms.	Discretion of staff
5. All participants shall be in and remain in their assigned rooms by scheduled curfew and doors shall remained closed until scheduled end of curfew.	Discretion of staff (Possibly) Lose participation rights
6. Participants shall not invite or receive visitors at the conference nor shall they leave the conference at any time.	Call to parents - send home
7. There shall be no room switching without the approval of the delegation advisor and the director/registrar of the conference.	Call to parents - send home
8. Participants must attend ALL sessions of the conference including meals.	Lose participation rights
9. Nametags shall be worn ONLY by the individual whose name appears on the badge and must be visible at all times.	Discretion of staff
10. Harassment or intimidation by words, gestures, body language, or any other menacing behavior will not be tolerated at all.	Discretion of staff (Possibly) Call Parents-send home (Possibly) Summon Security/Police
11. Each participant should conduct himself/herself in an orderly and responsible manner before, during, and after all functions of the conference. Personal behavior should reflect positively on one's self, family, club, and the YMCA.	Discretion of staff

If sent home for violation of this Agreement it will be at the expense of my parent or guardian.
